

## How Do I Comply?

### Prior to Construction

The Construction and Demolition Waste Reduction and Recycling Plan (C&D Recycling Plan) must be submitted to the Public Works Department prior to beginning construction.

### Choose a Recycling Method

Identify if you will be sorting recyclable materials into separate containers (source-separated), or if you will be combining (mixed) all materials into a single dumpster and having it hauled to a C&D sorting facility.

### Select a Hauler

For job that requires debris boxes, an Authorized C&D Hauler must be hired. You may self-haul recyclable materials from your site.

### Estimate, Track & Report

Estimate the C&D debris for your project, then track and report your diversion to the City.

### Completion of Project

All diversion information must be submitted with the final C&D Recycling Report at the end of project precedent to final inspection prior to the certificate of occupancy being approved.

## CONSTRUCTION & DEMOLITION RECYCLING PLAN

To be compliant with state mandates, the City of Fairfield's City Code requires that Construction and Demolition (C&D) projects divert 50% of their waste from entering the landfill.

Residential, commercial and industrial construction or demolition projects over 1,000 square feet must complete their Construction and Demolition Waste Reduction and Recycling Plan (C&D Recycling Plan) prior to beginning construction.

# Construction & Demolition Recycling

## C&D Recycling Plan

### 1. C&D Debris Materials Checklist

Estimate the debris from your project and submit the C&D Debris Material Checklist to Public Works for approval, then submit to the Building Department for your construction or demolition permit.

### 2. C&D Recycling Report

Track recycling and hauling activity from your job site. Then submit the information in your C&D Recycling Report along with required proof at the end of your project prior to final inspection.

## How to Meet Requirements

1. Hire an Authorized C&D Hauler to haul debris and recyclables. They can track information, and submit the C&D Recycling Report to the City for your project.
2. You may self-haul or sell the recyclables from your project. You must track all loads, keep weight tickets and receipts, and then submit the C&D Recycling Report to get credit for the diversion.



## Who's Affected?

If you have a residential, commercial or industrial construction and/or demolition project that is greater than 1,000 square feet, you will need to submit your C&D Materials Checklist to the Public Works Department before you will be issued a building permit.

You must make sure that the recycling and hauling activity is tracked through the entire project. All diversion information must be submitted with the final C&D Recycling Report at the end of the project prior to final inspection. The certificate of occupancy will not be issued without an approved C & D Recycling Plan.

## Submit C&D Recycling Plan

You may submit your C&D Recycling Plan online, or you may submit it via e-mail, fax or in person at Fairfield City Hall.
